Bid received in excess of the ABC Shall be automatically rejected at bid opening.
- 2) The City Government of Tanauan now invites bids for Supply and Delivery of Drugs and Medicines of the prospective bidder of all its ongoing and completed government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the relevant period. - (i) Bidding is restricted to Filipino citizens/sole proprietorships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4) Interested bidders may obtain further information from the City Government of Tanauan and inspect the Bidding documents at the address given below during 8:00 am to 5:00 pm.
- 5) A complete set of Bidding documents may be purchased by interested bidders on August 6, 2021 from the address below and upon payment of a nonrefundable fee amounting to Five Thousand Pesos (Php5,000.00) for the Bidding Documents in the amount based on the amount of project cost.
- 6) The Pre-bid conference is on 10:00 am August 13, 2021 at BAC Conference Room.
- 7) Bids must be delivered to the address below on or before 9:00 am August 25, 2021 All bids must be accompanied by a bid security in any of acceptable forms in the amount.
- A) Form of Security Minimum Amount in % of Approved Budget for the Contract to be Bid.
- 1)Cash, certified check, cashier's check, bank draft or irrevocable letter of credit. Two percent (2%)
- 2)Bank Guarantee two percent (2%)
- 3)Surety Bond five percent (5%)

Bid opening shall be on 10:00 am August 25, 2021 at BAC Conference Room. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
