### Description

- 1) The City Government of Tanauan, through the General Fund intends to apply the sum of PHP5,400,995.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of Grocery Items for Covid-19 Positive and PUI Patients. Bid received in excess of the ABC Shall be automatically rejected at bid opening.
- 2) The City Government of Tanauan now invites bids for Supply and Delivery of Grocery Items for Covid-19 Patients and PUI Patients of the prospective bidder of all its ongoing and completed government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the relevant period. The description of an eligible bidder is contained in the Bidding Documents particularly in Section II. Instruction to Bidders.

- 1. 2100 bags Rice/25 kilos
- 2. 2000 bags Rice/ 5 kilos
- 3. 240 boxes Sardines 155grams/box/100pcs
- 4. 165 boxes Corned Beef 155g/box/48pcs
- 5. 165 boxes Pork and beans 48's/box/175g
- 6. 165 boxes Tuna 155g/50pcs/box
- 7. 165 boxes Cup noodles 40q/48pcs/box
- 8. 85 boxes Cereal 40g/240pcs/box
- 9. 70 boxes Coffee 25g/60 pcs/box
- 3) Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- (i) Bidding is restricted to Filipino citizens/sole proprietorships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4) Interested bidders may obtain further information from the City Government of Tanauan and inspect the Bidding documents at the address given below during 8:00 am to 5:00 pm.
- 5) A complete set of Bidding documents may be purchased by interested bidders on October 20, 2021 from the address below and upon payment of a nonrefundable fee amounting to Ten Thousand Pesos (Php10,000.00) for the Bidding Documents in the amount based on the amount of project cost.
- 6) The Pre-bid conference is on 10:00 am October 28, 2021 at BAC Conference Room.
- 7) Bids must be delivered to the address below on or before 10:00 am November 10, 2021 All bids must be accompanied by a bid security in any of acceptable forms in the amount.
- A) Form of Security Minimum Amount in % of Approved Budget for the Contract to be Bid.
- 1)Cash, certified check, cashier's check, bank draft or irrevocable letter of credit. Two percent (2%)
- 2)Bank Guarantee two percent (2%)
- 3)Surety Bond five percent (5%)

Bid opening shall be on 10:00 am November 10,2021 at BAC Conference Room. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8) Pursuant to GPPB Circular 06-2005, in case the bid resulted into a tie and after determining the Lowest Calculated and Responsive Bidder (LCRB) and HRRB, Bid Evaluation and Post-qualification the BAC Members will convene and determine the winning bidder using the "Draw Lots" method.
- 9) The City Government of Tanauan reserved the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
