- 2) The City Government of Tanauan now invites bids for Supply and Delivery of Motor Vehicle of the prospective bidder of all its ongoing and completed government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, within the relevant period. The description of an eligible bidder is contained in the Bidding Documents particularly in Section II. Instruction to Bidders.

- 7) Bids must be delivered to the address below on or before 10:00am July 19, 2021. All bids must be accompanied by a bid security in any of acceptable forms in the amount.

- 2)Bank Guarantee two percent (2%)
- 3) Surety Bond five percent (5%)
